ANNOUNCEMENT

Admission of Graduate Students “MSc in Environmental Management and Sustainability”

1. The School of Economics, Business Administration and Legal Studies of the International Hellenic University invites interested parties to apply for the Postgraduate Programme of Studies "MSc in Environmental Management and Sustainability" for the academic year 2017-2018. All courses are taught exclusively in English.
The Academic Supervisor of the Postgraduate Programme of Studies is Prof. Eftichios Sartzetakis. The academics teaching on the programme come from universities both abroad and in Greece.
2. The postgraduate studies for this MSc programme lead to the acquisition of a Master's Degree. The programme curriculum requires the attendance of taught courses for two academic semesters for full-time students and the completion of a master's dissertation. There is also the possibility, upon request, of attending the programme on a part-time basis. In this case, the duration of the MSc will be double. The School reserves the right to not commence or to postpone commencement or not to offer the part time option of the programme due to insufficient enrolment or other unforeseen circumstances, at the absolute discretion of the Governing Board of the University. If a programme is cancelled or postponed, the University will refund any registration fees that have already been paid but cannot be held responsible for any other costs incurred or compensation for whatever other reason.
3. The International Hellenic University accepts, after a careful selection process, graduates from Greek universities or equivalent institutions from abroad as well as from Technological Educational Institutions in related subject areas.
The Postgraduate Programme of Study “MSc in Environmental Management and Sustainability“ has as its objective the provision of postgraduate level studies in Environmental Management and Sustainability and is designed for students and professionals or executives of businesses and organizations who wish to broaden their specialization in two directions, that of a) Environmental Management and b) Sustainable Management of businesses in the field of Tourism.

4. The selection of postgraduate students will be undertaken in accordance with the provisions of current legislation based on the relevance of the subject of the candidate's first degree with respect to the subject area of the postgraduate programme, the grades received in first degree qualifications, the grades received on the thesis and undergraduate courses related to the MSc in Environmental Management and Sustainability, the candidate's certified proficiency in the English language, the candidate's curriculum vitae and recommendation letters.
5. Interested parties are invited to submit their application by October 31st, 2017 or until places are filled, by following instructions at the link <http://www.ihu.edu.gr/index.php/admissions.html>.
 - A detailed curriculum vitae
 - A copy of the first degree (interested parties that expect to complete their first cycle studies in September may submit an application with their academic transcript so far)
 - Copy of the transcript of grades
 - Certification of English Language proficiency is demonstrated by submitting one of the following titles proving very good level: IELTS (6.5 or above), TOEFL (90 or above), TOEIC (850 or above). In case of absence of these, other certificates are also acceptable which prove, however, excellent knowledge of English, according to those standards designated by the Greek Authority ASEP. Candidates who do not possess the relevant certification may submit an application on the understanding that, in order to be allowed to commence Postgraduate Studies, they must submit such a certificate by October 31st, 2017
 - Two recommendation letters in signed and sealed envelopes. Alternatively, the referees can send the signed recommendation letters to infoseba@ihu.edu.gr by their official institutional email address
 - Two passport size photographs.
